







- Introduce positions of President elect and second past president so that all 5 different regional societies have a presidential position in each year

- Change transition date to close to 30th June as practical

Bylaws update to address succession - proposal



- Review proposed changes in a committee which has a nominee from each regional society
- 2. Circulate proposed changes and reasons for change to regional societies (via full WFPI Council) for comment.
- 3. Collate suggestions and make final recommendation for Bylaw changes to be put to each society via electronic ballot.
- 4. Implement changes to equalise representation ASAP












